

The Year 2013 marks another transition of the membership of the Municipal Council. It's election time and by law, the 8<sup>th</sup> Sanggunin has to end their term at noontime on June 30, 2103 and immediately the newly elected officials will assume their duties officially. A new composition of the 9<sup>th</sup> Sangguniang Bayan thus came into fore, where the former Local Chief Executive was resoundingly elected as the Vice-Mayor and Presiding Officer, four former members were re-elected and there were four newly elected members.

Handling the affairs of the Office of the Sangguniang Bayan, the legislative process was not too unfamiliar for the new Presiding Officer as he has dealt with it, being the Mayor of the town for the last nine (9) years. He has as a matter of record, introduced and initiated some vital pieces of legislation for the general observance and deferment of the populace including the unpopular but so important piece of law in environment preservation and climate change adaptation. The "no burning policy" became an issue in the elections but people realized that we really need significant laws as well as leaders with steely resolve and has the political will to institute genuine reforms in government.

The Internal Rules of Procedures was thus enacted with some minor amendments. Committee Chairmanships, Vice-Chairmanships, membership, District Barangay Assignments were properly done and the members were thus ready to buckle down to work.

With the new Mayor, the Executive and Legislative Agenda was deliberated fully to come up with a refined roadmap to development of the LGU. The Members actively participated in the formulation of the 2013-2016 Executive-Legislative Agenda (ELA). Cohesively working with the various departments of the Executive branch, the ELA was approved with the appropriate legislative actions on the different Projects, Programs and Activities (PPAs) presented by the Mayor. The timetables were set in accordance with the priority needs of the people as identified primarily based on the Comprehensive Development Plan (CDP) of the municipality. The ELA now serves as the guiding path to attain what was laid down as the main thrusts and concerns of the LGU in terms of community development.

For the year 2013, the Sangguniang Bayan adopted, passed and approved 156 resolutions, and 28 ordinances with a total of 139 measures. The resolutions cover governance, administration, social economic, environment and review actions of barangay legislations. The ordinances cover governance, administration, social, economic, environment, and participation.

The Sangguniang Bayan has also purchased modern equipment and fixtures to meet with the rapid advance of technology. The legislative tracking and filing has remarkably improved and all documents are made available to the public consistent with the constitutional provision that public documents be made accessible to the people.

With these, the new set of legislators yearn to work in unison for the common good, forget for the meantime, the divisiveness and disunity politics brings to the people and instead putting prime consideration to respond to the pressing needs of their constituents thru the enactment of significant laws truly supportive of the thrusts and programs of the Executive branch. Year 2013 is just the beginning but there are good indications that the 9<sup>th</sup> Sangguniang Bayan will continue to work as one team, ready to give their best in upholding their sworn duty as the chief legislators of the town.
