### ACCOMPLISHMENT REPORT FOR CALENDAR YEAR 2014

As mandated by the Local Government Code of 1991, the Sangguniang Bayan shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants. To fulfill this duty, it has to devise strategies and plans necessary to fully implement and carry out the plans of the executive branch. Thus, a responsive legislative agenda must be put in order and proper perspective which must be in harmony to the policy of the Chief Executive.

The 9<sup>th</sup> Sangguniang Bayan, deliberately and actively participated in the formulation of the 2013-2016 Executive-Legislative Agenda (ELA). Cohesively working with the various departments of the Executive branch, the ELA was approved with the appropriate legislative actions on the different Projects, Programs and Activities (PPAs) presented by the Mayor. The timetables were set in accordance with the priority needs of the people as identified primarily based on the Comprehensive Development Plan (CDP) of the municipality. The ELA now serves as the roadmap to attain what was laid down as the main thrusts and concerns of the LGU in terms of community development.

#### Innovations

For the effective implementation and carrying out the purposes of the local measures, a Legislative Oversight Committee was created. The committee is composed of five members elected from among the Sangguniang Bayan members and assisted by the Secretary to the Sangguniang Bayan.

In aid of legislations, its tasks are:

- a. To set the guidelines and overall framework to monitor and ensure the proper implementation of this Code;
- b. To ensure transparency and require the submission of reports from department heads or officials concerned on the conduct of programs, projects and policies relating to the implementation of this Code;
- c. To propose the allocation of budget for the programs of the Legislative Oversight Committee;
- d. To determine inherent weaknesses in the Code and recommend the necessary remedial legislation; and
- e. To perform such other duties, functions and responsibilities as may be necessary to effectively attain the objectives of this Code.

Also, in the interest of responsiveness, accountability, and transparency to legislative works and public governance, the works, accomplishments and on-going business of the Sangguniang Bayan can be searched in the municipality's website through <http://www.sannicolasilocosnorte.gov.ph/legislative.asp>. This aims to inform and educate researchers on the affairs of the Sangguniang Bayan, their works, and policies and programs formulated. ***The features of the Legislative Corner in the municipality's website include:***

The ***Sangguniang Bayan also partakes some of the executive functions***. By authority of the Mayor, they are tasked to look into the implementation of the laws they enact. Such is consistent with the principle of blending of powers to the benefit of the people. The EXPRESS Caravan is one avenue where the Sangguniang Bayan members mingle closer to the people, knowing their concerns and legislating the appropriate measures to address their problems.

For the year 2014, the Sangguniang Bayan adopted, passed and approved 141 resolutions, and 23 ordinances with a total of 164 measures. The resolutions cover governance, administration, social economic, environment and review actions of barangay legislations. The ordinances cover governance, administration, social, economic, environment, and participation.

The Sangguniang Bayan has also purchased modern equipment and fixtures to meet with the rapid advance and technology as well as the required one staff complement for each member and their respective individual office cubicles. The legislative tracking and filing has been remarkably improved and all documents are made available to the public consistent with the constitutional provision that public documents be made accessible to the people.

Good governance can only be attained through effective and responsive legislations. The LGU is faced with various challenges taking into consideration the complexities of roles and functions as embodied in the New Local Government Code. Local development in the grassroots can be attained through the collaborative efforts of the Executive and Legislative Departments. Priority thrusts of the Executive Department can never be realized without the appropriate legislative support emanating from the Sanggunian. Progress is manifest in San Nicolas. With all the significant legislations, we now see a town developed in almost all areas, in governance: economic and business, peace and order, culture and the arts, agriculture, environment, education and literacy, infrastructure and other priority areas.

With these, it is humbly submitted that the Executive Body cannot do it all by itself. It needs the support of a legislative Body whose members can rise above their self-interests, setting aside personal and political considerations and putting prime to respond to the pressing needs of their constituents thru the enactment of significant laws truly supportive of the thrusts and programs of the Executive branch. That is the Sangguniang Bayan of San Nicolas, ready to give their best in upholding their sworn duty as the chief legislators of the town.
