**“RESOLUTION NO. 2015-16**

**A RESOLUTION ADOPTING MUNICIPAL RESOLUTION NO. 2015-11 AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. MELANIE GRACE P. VALDEZ, M.D., TO ENTER INTO A CONTRACT OF SERVICE WITH DR. MODESTY LEAÑO, A LICENSED PATHOLOGIST TO PROVIDE SERVICES TO THE MUNICIPALITY OF SAN NICOLAS PARTICULARLY AT THE MUNICIPAL HEALTH OFFICE – LABORATORY DEPARTMENT.**

**WHEREAS**, the municipality is in need of the services of Dr. Modesty Leaño who shall perform work not performed by the regular personnel of the municipality;

**WHEREAS**, Dr. Modesty Leaño has signified his intention, to which the municipality has accepted, to provide the service needed by the latter;

**WHEREAS**, Dr. Modesty Leaño hereby possesses the education, experience and skills required to perform the job as described in the Contract of Service;

**WHEREAS**, Sec. 22 (c) of R.A. 7160, otherwise known as the Local Government Code of 1991 provides, that:

*Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:*

*(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.*

**WHEREAS**, the Municipal Mayor is empowered to enter into contracts or MOA's in behalf of the municipality. This is based on Section 444(b)(1)(vi) of the LGC of 1991 which provides:

*Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. –*  
xxx

*(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:*

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

**WHEREAS**, after thorough deliberation and consideration of the members of the Sangguniang Bayan on the proposed Contract of Service, it was:

**RESOLVED, AS IT IS HEREBY RESOLVED** that the Local Chief Executive Shall be Authorized to enter into a Contract of Service Dr. Modesty Leaño, a Licensed Pathologist to provide services to the Municipality of San Nicolas particularly at the Municipal Health Office – Laboratory Department.

**RESOLVED FURTHER** to transcribe copies of this resolution and furnish same to all concerned for their information, guidance and appropriate action.

On motion of Member Reynaldo Corpuz, duly seconded, the foregoing resolution was unanimously approved.


