AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 1 FOR FISCAL YEAR 2015 FROM THE CALENDAR YEAR 2014 RETAINED EARNINGS AMOUNTING TO P15,693,105.83 TO DEFRAY EXPENSES IN THE IMPLEMENTATION OF PROGRAMS, PROJECTS, AND ACTIVITIES OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE.

WHEREAS, pursuant to Supplemental Budget No. 1 for Fiscal Year 2015, there exists a retained earnings for Calendar Year 2014 amounting to Fifteen Million Six Hundred Ninety Three Thousand One Hundred Five Pesos 83/100 (P15,693,105.83) for various programs, projects and activities of the Municipality of San Nicolas, Ilocos Norte;

WHEREAS, the available funds are hereunder appropriated for the implementation of programs, projects, and activities of the municipality;
