"MUNICIPAL ORDINANCE NO. 2015-08

"AN ORDINANCE REVERTING THE SAVINGS FROM THE DESILTING OF SAN PABLO SMALL WATER IMPOUNDING PROJECT FROM RA 7171 EXCISE TAX IN THE AMOUNT OF NINE HUNDRED THIRTY NINE THOUSAND SEVEN HUNDRED SEVENTY FIVE PESOS AND 49/100 (P939,775.49) AND APPROPRIATING THE SAME FOR THE CONSTRUCTION OF SMALL WATER IMPOUNDING PROJECT AT BARANGAY 22, SAN GUILLERMO, THIS MUNICIPALITY IN RELATION TO THE MEMORANDUM OF AGREEMENT ENTERED INTO BY THE DEPARTMENT OF AGRICULTURE AND THE MUNICIPALITY DATED JUNE 30, 2014.

WHEREAS, there was a savings in the amount of P939,775.49 from the desilting of the San Pablo Small Water Impounding Project from RA 7171 Excises Tax;


WHEREAS, it has been stipulated in the Memorandum of Agreement that the necessary cost of the construction of the Catuguing Small Water Impounding Project was Thirteen Million Pesos (P13,000,000.00) but it has failed to include therein preparatory clearing and access roads which should be funded by the municipality for the expeditious and effective implementation of the said project;

WHEREAS, the said amount will be utilized primarily for the clearing operation as well as those not incorporated as part of the program of works identified to by the Department of Agriculture which was entrusted to the municipality;

WHEREAS, it is necessary to spend certain amounts to be utilized as oil, gasoline and lubricants for our equipments preparatory for the clearing and construction of the said project.

WHEREFORE, BE IT ENACTED, by the Sangguniang Bayan in session duly assembled that:

SECTION 1. There is a savings from the desilting of the Small Water Impounding Project of San Pablo in the Municipality's Share from RA 7171 Excise Tax amounting to **P939,775.49**;



SECTION 2. The amount of **P939,775.49** shall be reverted and hereby appropriated for the construction of Small Water Impounding Project at Barangay 22, San Guillermo, this municipality;

SECTION 3. *Effectivity.* - This ordinance shall take effect upon approval.
