"MUNICIPAL ORDINANCE NO. 2015-11

AN ORDINANCE REVERTING THE AMOUNT OF TWO MILLION SIX HUNDRED SEVENTY SEVEN THOUSAND TWO HUNDRED TWO PESOS AND TWENTY THREE CENTAVOS (P2,677,202.23) FROM THE PERSONAL SERVICES SAVINGS FROM JANUARY TO JUNE 2015 AND APPROPRIATING THE AMOUNT OF TWO MILLION THREE HUNDRED THIRTY SIX THOUSAND FOUR HUNDRED FORTY ONE PESOS (P2,336,441.00) FOR THE GRANT OF PRODUCTIVITY ENHANCEMENT INCENTIVE OF THE MUNICIPAL OFFICIALS AND EMPLOYEES OF THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE AS PER EXECUTIVE ORDER (EO) NO. 181.

WHEREAS, Executive Order (EO) No. 181 dated May 15, 2015 authorizes the Grant of the Productivity Enhancement Incentive (PEI) to qualified Government Officials and Employees;

WHEREAS, There is an available fund in the amount of Two Million Six Hundred Seventy Seven Thousand Two Hundred Two Pesos and Twenty Three Centavos (P2,677,202.23) representing Personal Services Savings (Vacant Positions) from January to June 2015;

WHEREAS, the Local Government Unit of San Nicolas, Ilocos Norte fully complied with the conditions set forth in the Executive Order (EO) No. 181;

WHEREAS, As per Executive Order (EO) No. 181, the Sanggunian shall ensure that the grant of Productivity Enhancement Incentive (PEI) is reasonable and that the expenditure will not, in any way, adversely affect the delivery of services to the public;

WHEREFORE, BE IT ENACTED, by the Sangguniang Bayan duly assembled that:

SECTION 1. There is an available amount of Two Million Six Hundred Seventy Seven Thousand Two Hundred Two Pesos and Twenty Three Centavos (P2,677,202.23) representing Personal Services Savings (Vacant Positions) from January to June 2015;

SECTION 2. The amount Two Million Six Hundred Seventy Seven Thousand Two Hundred Two Pesos and Twenty Three Centavos (P2,677,202.23) is hereby reverted and the amount of Two Million Three Hundred Thirty Six Thousand Four Hundred Forty One Pesos (P2,336,441.00) shall be appropriated for the grant of Productivity Enhancement Incentive to the Municipal Officials and Employees of the Municipality of San Nicolas, Province of Ilocos Norte.

SECTION 3. Separability Clause. - If any provision of this Ordinance or any part thereof be declared invalid or unconstitutional, the remaining provisions not affected thereby shall continue in full force and effect.


SECTION 3. Effectivity. This ordinance shall take effect upon approval.
