“RESOLUTION NO. 2015-22

A RESOLUTION EARNESTLY SEEKING CLARIFICATION AND GUIDANCE FROM THE COMMITTEE ON LABOR AND CIVIL SERVICE OF THE SANGGUNIANG PANLALAWIGAN AS TO ITS FINDINGS AND OBSERVATIONS REGARDING MUNICIPAL ORDINANCE NO. 2014-16 OF THE MUNICIPALITY OF SAN NICOLAS.

WHEREAS, Municipal Ordinance No. 2014-16 entitled, “An Ordinance Creating the Position of Municipal Disaster Risk Reduction and Management Officer (Salary Grade 18) Pursuant to Joint Memorandum Circular No. 2014-01 dated April 4, 2014 and the Philippine Disaster Risk Reduction and Management (PDRRM) Act of 2010” was adopted on July 21, 2014 of the Sangguniang Bayan (SB) of San Nicolas. After its approval on July 28, 2014, it was submitted to the Honorable Sangguniang Panlalawigan (SP) for review;

WHEREAS, more or less seven (7) months after its submission for review, on March 2, 2015, the SB received the Committee Report of the Committee on Labor and Civil Service returning the same based on the suggestions made by Ms. Nieves Duldulao of the Civil Service Commission as indicated in her comment dated August 18, 2014;

WHEREAS, the SB earnestly seeks clarification and guidance from the SP Committee on Labor and Civil Service on the following:

1. Is there a need to create an Office that is already mandatorily created by the national law, and that the adoption of the said Municipal Ordinance is merely to create the position to be added in the personnel of the Municipality?
2. Is there a need to specify in detail the source of funding when the Joint Circular No. 2014-01 has been integrated therein? If it will be stated as to be taken from the personal services, it must be noted that there is an exemption for its first year of assumption?
3. Are the provisions contained in the said Municipal Ordinance do not substantially comply with the requirements? and
4. What is now the status of said Ordinance especially so that an action was only made after seven months from its submission for review?

WHEREFORE, all the foregoing considered, and on unanimous motion of all the members present, be it resolved as it is hereby –

RESOLVED, to **EARNESTLY REQUEST CLARIFICATION** from the Committee on Labor and Civil Service the aforesaid queries so that the Municipality will be effectively guided with the same and will know what to do the matter; especially that the same is legally in effect considering that it was not expressly invalidated;

RESOLVED FINALLY, to transcribe and furnish this resolution to the aforesaid Committee on Labor and Civil Service of the Sangguniang Panlalawigan for its immediate consideration.
