“RESOLUTION NO. 2015-25

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE MELANIE GRACE P. VALDEZ, M.D., TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS REPRESENTED BY ITS OIC EXECUTIVE DIRECTOR ADELINA M. SUEMITH FOR THE PROJECT TITLED PRODUCTION OF INSTRUCTIONAL VIDEO “AGDAMDAMILI” THE OFFICIAL SONG AND DANCE OF SAN NICOLAS, ILOCOS NORTE.

WHEREAS, pursuant to RA 7356, the NCCA is mandated to encourage the continuing and balanced development of a pluralistic culture by the people, conserve and promote the nation’s cultural heritage, ensure the widest dissemination of artistic and cultural products and preserve and integrate traditional culture and its various creative expressions as a dynamic part of the national cultural mainstream;

WHEREAS, the local government unit aims to support projects on the cultural and economic developments of San Nicolas, Ilocos Norte;

WHEREAS, the PROJECT titled PRODUCTION OF INSTRUCTIONAL VIDEO “AGDAMDAMILI” THE OFFICIAL SONG AND DANCE OF SAN NICOLAS, ILOCOS NORTE is a production of the “Agdamdami” (Ilocano term for Pottery) instructional materials to educate students, researchers, and others who may have interest in the San Nicoleno culture;

WHEREAS, the NCCA recognizes the true worth of the Project as a contributory to the development of Philippine culture and arts and has seen it fit, proper and convenient to adopt the same for its own purposes.

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.
– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

WHEREFORE, be it RESOLVED as it is hereby resolved by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to enter Into a Memorandum of Agreement with the National Commission for Culture and the Arts Represented by its OIC Executive Director Adelina M. Suemith for the Project Titled Production of Instructional Video “Agdamdami” the Official Song and Dance of San Nicolas, Ilocos Norte.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;
