**“RESOLUTION NO. 2015-28**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE MELANIE GRACE P. VALDEZ, M.D., TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE EARLY CHILDHOOD CARE AND DEVELOPMENT COUNCIL (ECCDC) THROUGH ITS EXECUTIVE DIRECTOR DR. TERESITA G. INCIONG FOR THE ESTABLISHMENT OF A NATIONAL CHILD DEVELOPMENT CENTER IN THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE.**

**WHEREAS**, the Early Childhood Care and Development Council (ECCDC) would like to enter into a Memorandum of Agreement (MOA) with the Local Government Unit of San Nicolas for the establishment of a National Child Development Center in this municipality;

**WHEREAS**, said project will greatly benefit the constituents of San Nicolas most especially the children aged 0-4 years old, hence, there is a need to authorize the Local Chief Executive to enter into a Memorandum of Agreement with the above-mentioned national agency;

**WHEREAS**, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

*Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:*

xxx

xxx

*(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.*

**WHEREAS**, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

*Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.*

– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

**WHEREAS**, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

**RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to enter Into a Memorandum of Agreement with the Early Childhood Care and Development Council (ECCDC) through its Executive Director Dr. Teresita G. Inciong for the Establishment of a National Child Development Center in the Municipality of San Nicolas, Ilocos Norte.

**RESOLVED, FURTHER**, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;

On motion of Member Reynaldo A. Corpuz, duly seconded, foregoing resolution was unanimously approved.
