“RESOLUTION NO. 2015-30

A RESOLUTION FAVORABLY ENDORSING THE ESTABLISHMENT OF ANOTHER INFORMATION TECHNOLOGY BUILDING KNOWN AS THE VYV BUILDING AT THE SOUTH WESTERN PART OF THE VALDEZ CENTER ADJACENT TO THE NATIONAL HIGHWAY TO BE PRIMARILY INTENDED FOR BUSINESS PROCESS OUT-SOURCING (BPO) SERVICES AND TRANSMITTED TO THE PHILIPINE ECONOMIC ZONE AUTHORITY (PEZA) BOARD FOR THEIR CONSIDERATION.

WHEREAS, the VALDEZ CENTER was previously granted DAR Clearance and has been converted as Commercial/Industrial Site in the Municipality of San Nicolas, and has been considered as a zone for various commercial activities and has since been the host of various business establishment to the present;

WHEREAS, consistent with the commercial and industrial classification accorded to the said Valdez Center by existing DAR Clearances and the Municipal Zoning reclassification as well as pertinent zoning regulations, and in line with its existing policy of inviting possible investors to do business in the Municipality, the creation as well as establishment of additional business opportunities is most encouraged and highly welcomed;

WHEREAS, upon request of the management of the Valdez Center through its Vice-President, Mr. Ed Mar Vincent L. Bonoan of the Venvi Group of Companies and on unanimous consensus of this Body, IT IS HEREBY RESOLVED, as it is RESOLVED, to favorably indorse the establishment of another Information Technology Building to be primarily used as Business Process Out-Sourcing (BPO) Service Center at the South Western Part of the Valdez Center of San Nicolas, Ilocos Norte to the Honorable Board of the Philippine Economic Zone Authority (PEZA) in compliance with the provisions of Republic Act No. 7916 otherwise known as the Special Economic Zone Act of 1995; and

RESOLVED, finally, to furnish this resolution to the said PEZA Board for their consideration.


On motion of Member Reynaldo A. Corpuz, duly seconded, the foregoing resolution was unanimously approved.
