MUNICIPAL ORDINANCE NO. 2013-02

AN ORDINANCE TEMPORARILY CLOSING THE BARBA STREET, FROM MADAMBA STREET TO GENERAL LUNA STREET TO BE USED FOR THE LARO NG LAHI COMPETITION AS PART OF THE CELEBRATION OF THE 3RD FOUNDATION ANNIVERSARY OF DELASAN LEARNING CENTER INCORPORATED.

BE IT ENACTED, by the Sangguniang Bayan of the Municipality of San Nicolas, Province of Iloos Norte assembled in session that:

SECTION 1. The Barba Street, from Madamba Street to General Luna Street shall be temporarily closed on January 17, 2013 at 8:00AM-12:00 noon.
