“MUNICIPAL ORDINANCE NO. 2013-07

AN ORDINANCE APPROPRIATING THE AMOUNT OF TEN THOUSAND PESOS (P10,000.00) AS INCENTIVES OF THE PARTICIPANTS IN THE RECENTLY CONCLUDED SCHOOL-ON-THE-AIR (SOA): SANAYANG PANGRADYOSA AGRIKULTURA ON SUSTAINABLE RICE PRODUCTION TOGETHER WITH THE MUNICIPAL AGRICULTURIST, MRS. NORMA B. CALAMAYAN AND SCHOOL-ON-THE-AIR COORDINATOR, MR. LEOVIGILDO B. BUNGUBUNG, JR.

WHEREAS, as per certification of Ms. Maricel D. Dacapias, Information Officer II/Project Officer of the Agricultural Training Institute Regional Center – I, the municipality through the Municipal Agriculture Office garnered 1st Place, for having the highest number of graduates (95 participants) in the recently concluded School-On-The-Air (SOA): Sanayang Pangradyo sa Agrikultura on Sustainable Rice Production;

WHEREAS, for garnering such feat, the participants were awarded the amount of P10,000.00 as cash prize;
