“MUNICIPAL ORDINANCE NO. 2013-11

AN ORDINANCE REGULATING THE USE AND DISPOSITION OF THE TWO HUNDRED EIGHTY SIX (286) BOOKS – THE HISTORY OF SAN NICOLAS SECOND EDITION BY ATTY. MANUEL F. AURELIO.

WHEREAS, Two Hundred Eight Six (286) books of the “History of San Nicolas were acquired by the Municipality of San Nicolas, Ilocos Norte from its author, Atty. Manuel F. Aurelio;

WHEREAS, the books are primarily intended to be used as academic book in the schools of San Nicolas for the study of its history and culture;

WHEREAS, without accountability for the books they will not be kept with care;

WHEREAS, the books that will be distributed to the government schools of San Nicolas, Ilocos Norte shall be received as an accountable property of the Municipal Government of San Nicolas, Ilocos Norte;

WHEREAS, many students of the Municipality of San Nicolas, Ilocos Norte study in various schools in Ilocos Norte or research at the Provincial Library and Museum the same institutions will also be given copies of the book;

WHEREAS, the Municipality of San Nicolas, Ilocos Norte is regularly visited by officials from other places and the municipal government, through the Mayor, also visits municipalities and other places for cultural purposes, the Office of the Mayor should have copies of the book from which the Mayor could use as a gift from the Municipality of San Nicolas;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN NICOLAS, ILOCOS NORTE IN SESSION DULY ASSEMBLED, that:

SECTION 1. Title. - This ordinance shall be known as an “ORDINANCE REGULATING THE USE OF THE TWO HUNDRED EIGHTY SIX (286) BOOKS – THE HISTORY OF SAN NICOLAS SECOND EDITION BY ATTY. MANUEL F. AURELIO.

SECTION 2. *Distribution to Schools and San Nicolas (Damili) Learning and i Center .* - Of the Two Hundred Eighty Six books titled, "The History of San Nicolas Second Edition by Atty. Manuel F. Aurelio" acquired by the Municipality of San Nicolas Eighty Four (84) books shall be distributed by the Office of the Mayor through the Municipal Librarian to the respective principals of the following schools:

- a. San Nicolas Central Elementary School – Fifteen (15) books;
- b. Filipinas East Elementary School – Ten (10) books;
- c. Filipinas West Elementary School – Five (5) books;
- d. Eladio Barangan Memorial Elementary School – Five (5) books;
- e. Pasion Barangan Memorial Elementary School – Three (3) books;
- f. Asuncion Elementary School – Three (3) books;
- g. Barabar Elementary School – Three (3) books;
- h. Bingao Elementary School – Five (5) books;
- i. Bugnay Elementary School – Three (3) books;
- j. Catuguing Elementary School – Three (3) books;
- k. Cayetano Bumanglag Elementary School – Three (3) books;
- l. San Nicolas Main High School – Ten (10) books;
- m. Bingao High School (Annex) – Five (5) books;
- n. Sta. Rosa Academy Elementary – Three (3) books;
- o. Sta. Rosa Academy High School – Three (3) books; and
- p. Municipal Library – Five (5) books.

SECTION 3. *Accountability of Responsible Office.* - The books received by the principals of the schools mentioned in Section 2 and the Municipal Library shall be under their accountability as government property of the Municipality of San Nicolas.

SECTION 4. *Repository.* - The books received by the principals under Section 2 shall be kept in the respective school's library and made available to teachers and students, and the books of the Municipal Library shall be kept therein.

SECTION 5. *Inventory of Books Distributed.* - The Eighty Four (84) books mentioned under Section 2 shall be checked at the end of each school year by the Municipal Librarian and report on it to the Mayor in accordance to government property accountability.

SECTION 6. *Distribution of Books to Agencies and Institutions.* - In support of its social and cultural extension development program the Municipality of San Nicolas, through the Office of the Mayor shall give copies of the book to the libraries of schools and institutions as follows:

- a. Five (5) copies to the Provincial Library of Ilocos Norte;
- b. Three (3) copies for the Museum of Ilocos Norte;
- c. Three (3) copies for the Library of MMSU Batac Campus;
- d. Three (3) copies for the Library of Divine Word College of Laoag;
- e. Three (3) copies for the Library of Northwestern University;
- f. Two (2) copies for Northern Christian College;
- g. Two (2) copies for the Library of MMSU College of Education – Laoag City;
- h. Five (5) copies for Ilocos Norte National High School Library;
- i. Three (3) copies for the library of MMSU – Trade School.

SECTION 7. Eleven (11) books are hereby allotted and be given to sitting Vice-Mayor and Eleven (11) Members of the 8th Sangguniang Bayan.

SECTION 8. In support of the social and cultural development of San Nicolas wherein as a municipality, National and Local Officials from other places make official cultural or social visits and also in the same line the executive of the town also make such visits, Fifty (50) books are allotted for the Office of the Mayor for gift or representation purposes.



SECTION 9. The remaining One Hundred Twelve (112) books will be kept as reserve by the municipality as replenishment in the years to come for the books given to the government schools in San Nicolas mentioned in Section 2 including that of the Municipal Library.

SECTION 10. Sections 2 to 5 are not applicable to Sections 6 to 9 provided however that a book or books supplied as replenishment under Sections 2 to 4 shall be under Section 5;

SECTION 11. *Prohibition on Selling of Books.* - The sale of any of the Two Hundred Eight Six (286) books is hereby prohibited and punished.

SECTION 12. *Penalty.* - Any person who violates the provision of this ordinance shall be punished by a fine of Two Thousand Five Hundred (P2,500.00) or imprisonment of not more than six months or both at the discretion of the court.

SECTION 13. *Separability Clause.* - If for any reason, any section of this Ordinance is declared illegal or unconstitutional, other sections hereof which are not affected shall continue to be in full force and effect.

SECTION 14. *Repealing Clause.* - All previous issuances, ordinance, rules and regulations, provisions or parts thereof, which are inconsistent or in conflict with the provisions of this Ordinance, are hereby repealed or modified accordingly.

SECTION 15. *Effectivity Clause.* - This Ordinance shall take effect immediately upon approval.
