#### "MUNICIPAL ORDINANCE NO. 2013-12

AN ORDINANCE CONVERTING THE EXISTING POSITION OF ADMINISTRATIVE OFFICER-I WITH A SALARY GRADE OF 10 TO ADMINISTRATIVE OFFICER II WITH A SALARY GRADE 11, IN COMPLIANCE TO DEPARTMENT OF BUDGET CIRCULAR NO. 2004-03.

**WHEREAS**, the Sangguniang Panlalawigan in the exercise of its review powers over legislative measures passed by component legislative bodies within its jurisdiction, approved the 2013 annual budget of the municipality to be operative in part;

**WHEREAS**, the appropriation for the conversion of Administrative Officer II, (AO 1) SG 11/1 to Administrative Officer I (Supply Officer I), SG 10/1 was declared to be not in conformity with the provisions of Budget Circular No. 2004-03 of the Department of Budget and Management;

**WHEREAS**, it was recommended by the Provincial Finance Committee which was adopted by the Sangguniang Panlalawigan that the said position maybe converted/abolished and the appropriate position shall be created thru an ordinance;

### WHEREFORE, BE IT ORDAINED, THAT:

**SECTION 1**. The existing position of Administrative Officer I with Salary Grade 10 is hereby converted to Administrative Officer II with Salary Grade 11 and that the salary adjustments thereto shall be included in a separate appropriation ordinance.

**SECTION 2**. *Repealing Clause*. All ordinances, resolutions, executive orders or regulations and other issuances inconsistent with the provisions and/or purpose of this ordinance.

**SECTION 3**. *Effectivity*. This ordinance shall take effect upon approval.
