“MUNICIPAL ORDINANCE NO. 2013-13

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 2 FOR FISCAL YEAR 2013 INVOLVING THE APPROPRIATION OF THE AMOUNT OF NINE THOUSAND ONE HUNDRED TWENTY FIVE PESOS AND SEVENTY SIX CENTAVOS (P9,125.76) FROM THE APPROPRIATED LUMP SUM FOR SALARY INCREASE TO COVER THE DIFFERENCE IN SALARY GRADE FOR THE CONVERSION OF THE POSITION ADMINISTRATIVE OFFICER I TO ADMINISTRATIVE OFFICER II.

WHEREAS, There is an available fund in the Annual Budget of 2013 under the personal services amounting to One Million Seven Hundred Twenty Seven Thousand Seven Hundred Thirty Eight Pesos and Ninety Centavos (P1,727,738.90) intended for the increase of salaries;

WHEREAS, pursuant to Supplemental Budget No. 2 dated July 19, 2013, a portion of the aforesaid amount shall be appropriated to cover the difference in salary grade for the conversion of the position of Administrative Officer I to Administrative Officer II;

WHEREFORE, BE IT ENACTED, by the Sangguniang Bayan duly assembled that:

SECTION 1. The amount of Nine Thousand One Hundred Twenty Five Pesos and Seventy Six Centavos (P9,125.76) for the salary increase is hereby appropriated to cover the difference in salary grade for the conversion of the position of Administrative Officer I to Administrative Officer II to be taken from the unappropriated personnel services lump sum provision.

SECTION 2. Effectivity. This ordinance shall take effect upon approval.
