“MUNICIPAL ORDINANCE NO. 2013-14

AN ORDINANCE IMPOSING FEES FOR LABORATORY AND HEALTH RELATED EXAMINATIONS CONDUCTED IN THE MUNICIPAL HEALTH CENTER AND PROVIDING EXEMPTIONS THERETO.

“Be it enacted by the Sangguniang Bayan in session duly assembled:

SECTION 1. IMPOSITION OF FEES. Section 1, Chapter V, Article G of Municipal Ordinance No. 2008-26 otherwise known as the Municipal Revenue Code of 2008 is hereby amended to read as follows:

SECTION 1. Imposition of Fees. There shall be imposed laboratory or health examination or certification fee from any person who have undergone a physical or laboratory examination at the Municipal Health Office as follows:

Laboratory Test Fee

Hepatitis Screening (Hbsag)	150.00
Blood Urea Nitrogen (BUN)	150.00
Creatinine (CREA)	150.00
Blood Uric Acid (BUA)	150.00
Total Cholesterol (TC)	180.00
Triglyceride (TG)	180.00
Good Cholesterol (HDL)	180.00
Bad Cholesterol (LDL)	180.00
Pregnancy Test	120.00
Platelet Count	100.00

Other Related Services

Drug Testing	250.00
X-Ray	270.00
Electrocardiograph (ECG)	300.00

The aforesaid respective fee/s shall be paid to the Municipal Treasurer's Office before the health, laboratory or related service is made and result of examination thereof is issued.

SECTION 2. EXEMPTIONS AND DISCOUNTS. The following persons shall be exempted from the payment of any of the aforesaid fees: (a) senior citizens as provided for in Section 4 of Republic Act No. 9994 also known as the "Expanded Senior Citizens Act of 2010"; and (b) indigent residents of the municipality who are registered as such at the Municipal Social Welfare Office (MSWO). To avail such exemption, the concerned person in letter (a) shall show proof that he/she is indeed a senior citizen or any competent evidence such as birth certificate and validly issued senior citizen I.D., while those in letter (b) shall submit a certification of indigency duly issued by the MSWO of the municipality.

Persons With Disabilities (PWD's) shall be entitled to twenty percent (20%) discount on the aforesaid fees imposed by this ordinance as provided for in Section 3, Article B, Chapter XVII, Book II of Municipal Ordinance No. 2009-12.

SECTION 3. EXAMINATION RECORDS AND EVALUATION AND REPORTORIAL REQUIREMENTS. - The Municipal Health Office shall keep a complete record of laboratory and health examinations conducted indicating the name of the patient/client, findings of the examination/s, as well as the date and the purpose for which the examination was made.

The Local Health Board (LSB) shall oversee, and undertake periodic evaluation on, the effective implementation hereof and shall, from time to time, make necessary recommendations to the Sangguniang Bayan on the possible changes of fees imposed herein, as circumstances warrant.

SECTION 4. EFFECTIVITY. This Ordinance shall take effect ten (10) days from the completion of its publication as required under Section 188 of Republic Act 7160 otherwise known as the Local Government Code of 1991.
