**“MUNICIPAL ORDINANCE NO. 2013-17**

**AN ORDINANCE APPROPRIATING THE AMOUNT OF TWO MILLION NINE HUNDRED SEVENTY-TWO THOUSAND SIX HUNDRED TWENTY-SIX PESOS (P2,972,626.00) REPRESENTING THE DIRECT SHARES OF THE MUNICIPALITY FROM THE FY 2011 VIRGINIA TOBACCO EXCISE TAX PURSUANT TO REPUBLIC ACT NO. 7171 WHICH AMOUNTS TO TWO MILLION NINE HUNDRED FIFTY-EIGHT THOUSAND FOUR HUNDRED FORTY-EIGHT PESOS (P2,958,448.00) AND THE 4<sup>TH</sup> INSTALLMENT OF THE UNRELEASED SHARES OF THE LGUs FROM THE FYs 1997-2007 BURLEY AND NATIVE TOBACCO TAX COLLECTIONS PURSUANT TO REPUBLIC ACT NO. 8240 WHICH AMOUNTS TO FOURTEEN THOUSAND ONE HUNDRED SEVENTY-EIGHT PESOS (P14,178.00) FOR VARIOUS INFRASTRUCTURE PROJECTS OF THE MUNICIPALITY.**

**WHEREAS**, there exists direct shares of the municipality from the FY 2011 Virginia Tobacco Excise Tax pursuant to Republic Act No. 7171 which amounts to Two Million Nine Hundred Fifty-Eight Thousand Four Hundred Forty-Eight Pesos (P2,958,448.00) and the 4<sup>th</sup> Installment of the Unreleased Shares of the LGUs from the FYs 1997-2007 Burley and Native Tobacco Tax Collections Pursuant to Republic Act No. 8240 which amounts to Fourteen Thousand One Hundred Seventy-Eight Pesos (P14,178.00);

**WHEREAS**, the said Tobacco Excise Tax Collections are allocated for the different infrastructure projects of the municipality;

**WHEREFORE, BE IT ENACTED**, by the Sangguniang Bayan in session duly assembled that:

**SECTION 1.** There are direct shares of the municipality pursuant to Republic Act No. 7171 in the amount of P2,958,448.00 and Burley and Native Tobacco Tax Collections pursuant to Republic Act No. 8240 in the amount of P14,178.00;

**SECTION 2.** The amount of P2,972,626.00 shall be appropriated for the following infrastructure projects of the municipality:

1. Concrete Paving of Farm to Market Road at Brgy. 21, San Agustin; P1,522,626.00

2. Concrete Paving of Farm to Market Road P1,450,000.00  
along NIA Access Road from MNR to Nalundasan

Road at Brgy. 16, San Marcos.
