“MUNICIPAL ORDINANCE NO. 2013-21

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 3 FOR FISCAL YEAR 2013 INVOLVING THE AMOUNT OF TWO HUNDRED FIFTY THREE THOUSAND THREE HUNDRED NINETY PESOS (P 253,390.00) TO DEFRAY EXPENSES IN THE IMPLEMENTATION OF PROGRAMS AND PROJECTS OF THE MUNICIPALITY.

WHEREAS, There is an available fund in the amount of Two Hundred Fifty Three Thousand Three Hundred Ninety Pesos (P253,390.00) representing Increase in IRA from January to August, 2013;

WHEREAS, the said available funds are hereunder appropriated for the developmental expenses of the municipality.

WHEREFORE, BE IT ENACTED, by the Sangguniang Bayan duly assembled that:

SECTION 1. There is an available amount of Two Hundred Fifty Three Thousand Three Hundred Ninety Pesos (P 253,390.00) representing Increase in IRA from January to August, 2013;

SECTION 2. The aforesaid amount of Two Hundred Fifty Three Thousand Three Hundred Ninety Pesos (P 253,390.00) representing Increase in IRA from January to August, 2013 shall be appropriated as follows:
