“MUNICIPAL ORDINANCE NO. 2013-25

AN ORDINANCE CREATING THE POSITIONS OF NURSE I AND MEDICAL TECHNOLOGIST I IN THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE AND APPROPRIATING FUNDS THEREFOR.

“Be it enacted by the Sangguniang Bayan in session duly assembled:

WHEREAS, the Municipality, pursuant to its mandate to promote the general welfare of its constituents as enunciated in Section 16 of the Local Government Code, there is an imperative need to improve health and other allied services by way of adding needed personnel of the Municipal Health Office (MHO) consistent with all healthcare related programs that has been previously ordained for the benefit of all;

WHEREAS, consistent with the power vested to the Municipality to create such other positions or offices as may be necessary to carry out the purposes and programs of the municipality as enunciated under the Local Government Code, it finds a compelling necessity to have Nurse I and Medical Technologist I to bolster the healthcare services for its constituents;

NOW, THEREFORE, BE IT ORDAINED THAT:

SECTION 1. *Creation of the position of Nurse I, its qualifications, duties and functions.*

The position of Nurse I is hereby created with a corresponding salary grade (SG) 11 in accordance with Local Budget Circular No. 2009-92 who shall be under the direct supervision of the Municipal Health Office (MHO). He/she shall be a holder of Bachelor of Science in Nursing, and has the mandatory eligibility required by Republic Act 1080 (Registered Nurse) as indicated and prescribed by the Qualification Standards Manual and other existing rules and regulations. In addition, he/she shall be of good moral character, a citizen of the Republic of the Philippines and a *bona fide* resident of the local government unit of San Nicolas, Ilocos Norte.

As Nurse I, he/she shall have the duties and functions extant and pertinent to his/her profession as prescribed by the Municipal Health Officer and the appointing authority.

SECTION 2. Creation of the position of Medical Technologist I, its qualifications, duties and functions. The position of a Medical Technologist I is hereby created with a corresponding salary grade (SG) 11 in accordance with the Local Budget Circular No. 2009-92, and who shall be under the direct supervision of the Municipal Health Office (MHO). He/she shall be a holder of a Bachelor's degree in Medical Technology and has the mandatory eligibility required by Republic Act No. 1080 (Registered Medical Technologist) as indicated and prescribed by the Qualification Standards Manual and other existing rules and regulations. In addition, he/she shall be of good moral character, a citizen of the Republic of the Philippines and a *bona fide* resident of the local government unit of San Nicolas, Ilocos Norte.

As Medical Technologist I, he/she shall have the duties and functions extant and pertinent to his/her profession as prescribed by the Municipal Health Officer and the appointing authority.

SECTION 3. Appointing Authority. The Nurse I and Medical Technologist I shall be appointed by the Local Chief Executive of the municipality consistent with Section 444 (b)(1)(v) of the Local Government Code.

SECTION 4. Appropriations. The required funds for the salaries, allowances and benefits accruing in the said positions shall be included in the municipal Annual Budget for FY 2014 and, thereafter, to subsequent annual appropriations subject to personal services limitations provided for under Section 345 of the Local Government Code.

SECTION 5. Effectivity. This ordinance shall take effect ten (10) days after posting the same in the Bulletin Board at the entrance of the Municipal Hall and two (2) other conspicuous places in the municipality.
