“MUNICIPAL ORDINANCE NO. 2013-28

AN ORDINANCE REVERTING THE AMOUNT OF FOUR MILLION FOUR HUNDRED ONE THOUSAND TWO HUNDRED THIRTY SIX PESOS AND SEVENTY TWO CENTAVOS (P4,401,236.72) FROM THE PERSONAL SERVICES SAVINGS FROM JANUARY TO DECEMBER 2013 AND APPROPRIATING THE AMOUNT OF FOUR MILLION FOUR HUNDRED THOUSAND FIVE HUNDRED SEVENTY SEVEN PESOS AND THIRTY SEVEN CENTAVOS (P4,400,577.37) FOR THE PRODUCTIVITY ENHANCEMENT INCENTIVE OF THE MUNICIPAL OFFICIALS AND EMPLOYEES AS PER DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) LOCAL BUDGET CIRCULAR NO. 2013-3 AND FOR VARIOUS PROGRAMS AND PROJECTS OF THE MUNICIPALITY.

WHEREAS, Department of Budget and Management (DBM) Local Budget Circular No. 2013-3 dated November 21, 2013 authorizes the Grant of the Productivity Enhancement Incentive (PEI) to Government Employees;

WHEREAS, There is an available fund in the amount of Four Million Four Hundred One Thousand Two Hundred Sixty Three Pesos and Seventy Two Centavos (P4,401,263.72) representing Personal Services Savings (Vacant Positions) from January to December 2013;

WHEREAS, As per Department of Budget and Management (DBM) Local Budget Circular No. 2013-3, the Sanggunian shall ensure that the grant of Productivity Enhancement Incentive (PEI) is reasonable and that the expenditure will not, in any way, adversely affect the delivery of services to the public;

WHEREFORE, BE IT ENACTED, by the Sangguniang Bayan duly assembled that:

SECTION 1. There is an available amount of Four Million Four Hundred One Thousand Two Hundred Thirty Six Pesos and Seventy Two Centavos (P4,401,236.72) representing Personal Services Savings (Vacant Positions) from January to December 2013;

SECTION 2. The amount of Four Million Four Hundred One Thousand Two Hundred Sixty Three Pesos and Seventy Two Centavos (P4,401,263.72) is hereby reverted and the amount of Four Million Four Hundred Thousand Five Hundred Seventy Seven Pesos and Thirty Seven Centavos (P4,400,577.37) shall be appropriated for the grant of Productivity Enhancement Incentive to the Municipal Officials and Employees, Cash Gift and Year End Bonus for new Sangguniang Bayan Members and for various programs and projects of the Municipality of San Nicolas, Province of Ilocos Norte;

SECTION 3. Effectivity. This ordinance shall take effect upon approval.
