“MUNICIPAL ORDINANCE NO. 2014-05

AN ORDINANCE APPROPRIATING THE AMOUNT OF TWO MILLION SEVEN HUNDRED FIFTY ONE THOUSAND THREE HUNDRED EIGHTY SEVEN PESOS (P2,751,387.00) REPRESENTING THE DIRECT SHARES OF THE MUNICIPALITY FROM THE FY 2011 VIRGINIA TOBACCO EXCISE TAX PURSUANT TO REPUBLIC ACT NO. 7171 FOR VARIOUS INFRASTRUCTURE PROJECTS OF THE MUNICIPALITY.

WHEREAS, the Department of Budget and Management has issued a Notice of Funding Check dated September 12, 2013 on the Remaining Balance of the FY 2011 shares of the municipality on the Virginia Tobacco Excise Tax pursuant to Republic Act No. 7171 which amounts to Two Million Seven Hundred Fifty One Thousand Three Hundred Eighty Seven Pesos (P2,751,387.00);

WHEREAS, the said Tobacco Excise Tax Share of the municipality are allocated for the different infrastructure projects and programs of San Nicolas;

WHEREFORE, BE IT ENACTED, by the Sangguniang Bayan in session duly assembled that:

SECTION 1. There is a direct share of the municipality pursuant to Republic Act No. 7171 in the amount of P2,751,387.00;

SECTION 2. The amount of P2,751,387.00 shall be appropriated for the following infrastructure projects of the municipality:
