**“MUNICIPAL ORDINANCE NO. 2016-03**

**AN ORDINANCE RENAMING THE BINGAO CAMPUS (ANNEX) OF THE SAN NICOLAS NATIONAL HIGH SCHOOL TO BINGAO NATIONAL HIGH SCHOOL.**

**WHEREAS**, the segregation or separation of the *Bingao Campus Annex* of the *San Nicolas National High School* (SNNHS) has been approved, and was granted an independent status from its mother school effective school year 2015-2016;

**WHEREAS**, after consultation with all stakeholders, the Municipal School Board adopted MSB Resolution No. 2014-02 recommending the renaming of the same to BINGAO NATIONAL HIGH SCHOOL (BNHS) as its distinct and separate identity;

**WHEREAS**, the recommended name is consistent with the cultural and traditional identity of the location of said school as the same area was popularly and historically known and referred to as *BINGAO* - a cluster of several community of the municipality of San Nicolas, Ilocos Norte. The name *BINGAO* has evolved since time immemorial as a significant historical name of a place in the municipality of San Nicolas particularly along the stretch of the national highway going to Batac City.

**WHEREAS**, the renaming will avoid confusion as to its identity with its mother school;

**WHEREFORE**, pursuant to the authority granted under the Section 13(c) of Republic Act 7160, be it enacted by the Sangguniang Bayan in session duly assembled:

**SECTION 1.** The SAN NICOLAS NATIONAL HIGH SCHOOL (SNNHS) - BINGAO Campus (Annex) shall be known and renamed as BINGAO NATIONAL HIGH SCHOOL (BNHS).


**SECTION 2.** This ordinance shall take effect ten (10) days after compliance with the posting requirements provided for under Section 59 of the Local Government Code.


