#### "MUNICIPAL ORDINANCE NO. 2016-05

AN ORDINANCE DECLARING MRS. PAULINA "NANA PAUL" RANGCAPAN OF BARANGAY 8, SAN RUFINO AS MUNICIPAL LIVING TREASURE AND PROVIDING HER THE INCENTIVES FOR THIS PURPOSE.

WHEREAS, in 2006, the municipal government through Municipal Resolution No. 2006-81 bestowed upon Mrs. Paulina "Nana Paul" Rangcapan the "San Nicolense of the Year Award – Local", the highest and most prestigious award given to an individual as a recognition of the awardee's illustrious achievements in the service of the people;

WHEREAS, Nana Paul has been described as a symbol of the "San Nicoleños' industry and persistence in attaining what is next to impossible, that is to raise a decent family, through her bare hands and tender body, and her persistence in traditional pottery speaks of her endurance and love for her craft and commitment of promoting the centuries old industry. It keeps her connected to the municipality's history, culture, and values. More importantly, her being a 'creator' as well as a promoter herself of the industry is a powerful proof of her role in society. She is a living lesson in nobility and loyalty to tradition. She is a picture of success in her own right."

**WHEREAS,** further, she is a visible representation of cultural awareness and appreciation producing earthenware products of artistic, distinctive, and superior quality and functional literacy programs of the municipality that through her crafts and skills genuine sustainable development abound in the municipality;

**NOW, THEREFORE, BE IT ORDAINED** by the Sangguniang Bayan of San Nicolas, Ilocos Norte, in session duly assembled, that:

**SECTION 1.** *Declaration.* – It is hereby declared that Mrs. Paulina "Nana Paul" Rangcapan of Barangay 8, San Rufino, this municipality, as Municipal Living Treasure. This declaration aims to honor and support her outstanding sociocultural contributions to the municipality and to see to it that her skills and crafts are preserved and the transfer of her skills to new generations is ensured.

**SECTION 2.** *Provision of Incentives and Allocation of Fund.* - The amount of P3,000.00 as earmarked from the Annual Budget of the municipality (Incentives to Cultural Workers) is hereby granted and be released monthly. Thereafter, the municipal government shall allocate the necessary amount for this purpose in the annual and/or supplemental budget of the municipality.

**SECTION 3.** Separability Clause. - If for any reason, any section of this Ordinance is declared illegal or unconstitutional, other sections hereof which are not affected shall continue to be in full force and effect.

**SECTION 4.** *Repealing Clause.* - All previous issuances, ordinance, rules and regulations, provisions or parts thereof, which are inconsistent or in conflict with the provisions of this Ordinance, are hereby repealed or modified accordingly.

**SECTION 5.** Effectivity Clause. - This Ordinance shall take effect immediately upon approval.
