AN ORDINANCE REVERTING THE AMOUNT OF TWO MILLION TWO HUNDRED TWENTY SEVEN THOUSAND NINE HUNDRED NINETY FIVE PESOS AND TWENTY THREE CENTAVOS (P2,227,995.23) FROM THE PERSONAL SERVICES SAVINGS OF VACANT POSITIONS FROM APRIL TO JULY 2016 AND APPROPRIATING THE SAME FOR THE GRANT OF PRODUCTIVITY ENHANCEMENT INCENTIVE, TERMINAL LEAVE BENEFITS, AND OTHER BENEFITS TO ALL QUALIFIED MUNICIPAL OFFICIALS AND EMPLOYEES AND OTHER PROGRAMS OF THE MUNICIPALITY.
