“MUNICIPAL ORDINANCE NO. 2016-08

AN ORDINANCE INSTITUTIONALIZING THE GRANT OF FREE BIRTHDAY PACKAGE TO SENIOR CITIZENS AND PERSONS WITH DISABILITIES (PWDs) OF THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE AND FOR OTHER PURPOSES.

Be it Enacted by the Sangguniang Bayan in session duly assembled, that:

SECTION 1. Title. - This Ordinance shall be known as “Senior Citizens and Persons with Disabilities Free Birthday Package Ordinance of the Municipality of San Nicolas.”

SECTION 2. Statement of Objectives. –This Ordinance aims:

- a) To substantiate the much valued Filipino tradition of caring for the disabled and to provide them quality recreation and gladness with least expense;
- b) To cultivate in the minds of the disabled that they are not discarded in the community they live in, and radiate in them hope and trust that there is a government that cares for them, consistent with established norms and values as advocated by national laws;
- c) To institute an active partnership of the Municipality, Office of the OSCA and Persons with disabilities in the improvement of the welfare of the elderly differently-abled persons.

SECTION 3. Grant of Privilege. - Pursuant to Section 2 hereof, a privilege which shall be known as a Free Birthday Package can be availed of by any senior citizen and person with disability in the municipality. The availment of the birthday package shall be under the supervision of the Office of Social Services in coordination with the Office of Senior Citizens and Persons with Disabilities.

SECTION 4. Coverage. – All senior citizens and persons with disabilities recognized by the municipality as qualified shall enjoy the free birthday package in the municipality.

SECTION 5. Qualifications. – Any senior citizen and person with disabilities is entitled to the above mentioned privileges provided he/she meets the following requirements:

- a) He/she must be a bona-fide resident of the municipality for at least one (1) year; and
- b) He/she is a recognized member of Senior Citizen and Person With Disabilities association in the Barangay as duly noted in the offices of the Punong Barangay, OSCA and PWDs affairs.

SECTION 6. Mechanism and Procedures. – Once a person is recognized as qualified to avail of the free birthday package, he/she shall be issued a specially designed Identification Card by the Office of the Mayor in coordination with the Office of the OSCA and PWDs’ Affairs.

SECTION 7. Appropriation of funds. Funds for the purpose of the implementation of this ordinance shall come from the General Fund under the allocations for Senior Citizens and PWDs.

SECTION 8. Separability Clause. If, for any reason any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.




