**“MUNICIPAL ORDINANCE NO. 2016-13**

**AN ORDINANCE TEMPORARILY CLOSING THE ROAD NORTH OF THE SAN NICOLAS MUNICIPAL HALL BUILDING TO BE USED FOR THE AGRI-INDUSTRIAL TRADE FAIR AND EXHIBIT DURING THE PERIOD OF DECEMBER 23-30, 2016.**

**BE IT ENACTED**, by the Sangguniang Bayan of the Municipality of San Nicolas, Province of Ilocos Norte assembled in session that:

**SECTION 1.** The road north of the San Nicolas Municipal Hall Building shall be temporarily closed during the period of December 23-30, 2016.

**SECTION 2.** The area shall be used for the Agri-Industrial Trade Fair and Exhibit as part of the celebration of the Damili Festival 2016.

**SECTION 3.** This ordinance shall take effect upon approval.
