**“MUNICIPAL ORDINANCE NO. 2017-04**

**AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 1 FOR FISCAL YEAR 2017 FROM THE CALENDAR YEAR 2016 RETAINED EARNINGS AMOUNTING TO THIRTEEN MILLION FOUR HUNDRED TWENTY SIX THOUSAND TWO HUNDRED TWENTY NINE PESOS AND THIRTY SEVEN CENTAVOS (P13,426,229.37) TO DEFRAY EXPENSES IN THE IMPLEMENTATION OF PROGRAMS, PROJECTS, AND ACTIVITIES OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE.**

**WHEREAS**, pursuant to Supplemental Budget No. 1 for Fiscal Year 2017, there exists a retained earnings for Calendar Year 2016 amounting to Thirteen Million Four Hundred Twenty Six Thousand Two Hundred Twenty Nine Pesos and Thirty Seven Centavos (P13,426,229.37) for various programs, projects and activities of the Municipality of San Nicolas, Ilocos Norte;

**WHEREAS**, the available funds are hereunder appropriated for the implementation of programs, projects, and activities of the municipality;

**WHEREFORE, BE IT ENACTED**, by the Sangguniang Bayan in session duly assembled that:

**SECTION 1.** There is an existing retained earnings in the amount of **P13,426,229.37**.


**SECTION 3. Effectivity.** - This ordinance shall take effect upon approval.
