“MUNICIPAL ORDINANCE NO. 2017-08

**AN ORDINANCE ENACTING THE DAMILI LEGISLATIVE PROGRAM
AND FOR OTHER PURPOSES.**

SECTION 1. *Title.* – This Ordinance shall be known as “Damili Legislative Program.”

SECTION 2. *Statement of Policy.* – It is hereby declared the policy of the Municipality to attain its fullest development as self-reliant community and be more effective partner in the attainment of national goals. Toward this end, the Municipality shall provide for a more responsive and accountable legislations instituted through effective and efficient capacity building programs to the Barangays, generate more public information and awareness and participation, and sound government practices.

SECTION 3. *Nature of the Legislative Program.* – This Ordinance hereby strengthens Municipal Ordinance No. 2014-01 known as “*Barangay Governance Performance Awards and Citations Ordinance of the Municipality of San Nicolas*” and the role of the Sangguniang Bayan in the exercise of its review power over the legislative measures adopted or passed by the Sangguniang Barangays.

Nothing in this Ordinance, however, that shall be construed as interfering or undermining the duties and functions of the Sangguniang Barangay.

SECTION 4. *Damili Legislative Program.* – The Damili Legislative Program shall encompass the following:

1. The Sangguniang Bayan shall conduct effective and efficient capacity building programs to the Punong Barangays, Members of the Sangguniang Barangay, Barangay Secretaries, Barangay Treasurers, and other barangay functionaries on matters relating to legislative processes and procedures.

The Committee on Barangay Affairs and Committee on Laws, Good Government, and Rules and Ethics shall formulate a responsive and appropriate modules for this purpose within thirty (30) days from the date of approval of this Ordinance.

The Selection Committee created under Municipal Ordinance No. 2014-01 shall present a post evaluation report as part of the Modules on capacity building.

- 2. The Sangguniang Bayan Secretariat shall integrate and upload in the website of the Municipal Government or the link page of the Sangguniang Bayan if it deems necessary the action or actions taken by the Sangguniang Bayan on matters relating to its review power within three (3) days from the date its resolution for easier access.

SECTION 5. *Funding.* - During the initial year of the implementation of this Ordinance, the requisite funds shall be sourced from any available funds of the local government unit of San Nicolas, Ilocos Norte. Subsequently, the amount necessary to implement the provisions of this Ordinance shall be included in the succeeding Annual Budgets.

SECTION 6. *Separability Clause.* - If for any reason, any section of this Ordinance is declared illegal or unconstitutional, other sections hereof which are not affected shall continue to be in full force and effect.

SECTION 7. *Repealing Clause.* - All previous issuances, ordinance, rules and regulations, provisions or parts thereof, which are inconsistent or in conflict with the provisions of this Ordinance, are hereby repealed or modified accordingly.


SECTION 8. *Effectivity.* - This ordinance shall take immediately upon approval.
