“MUNICIPAL ORDINANCE NO. 2017-12

AN ORDINANCE REVERTING THE AMOUNT OF TWO MILLION NINE HUNDRED SEVENTEEN THOUSAND EIGHT HUNDRED SEVENTEEN PESOS AND FOUR CENTAVOS (P2,917,817.04) FROM THE PERSONAL SERVICES SAVINGS OF VACANT POSITIONS FROM JANUARY TO JUNE 2017 AND APPROPRIATING THE SAME FOR THE GRANT OF PRODUCTIVITY ENHANCEMENT INCENTIVE, TERMINAL LEAVE BENEFITS AND MONETIZATION OF LEAVE CREDITS TO ALL QUALIFIED MUNICIPAL OFFICIALS AND EMPLOYEES AND OTHER PROGRAMS OF THE MUNICIPALITY.

WHEREAS, pursuant to Supplemental Budget No. 2 for Fiscal Year 2017, there exists an available fund in the amount of Two Million Nine Hundred Seventeen Thousand Eight Hundred Seventeen Pesos and Four Centavos (P2,917,817.04) representing Personal Services Savings (Vacant Positions) from January to June 2017;

WHEREAS, the available funds are hereunder appropriated for the grant of productivity enhancement incentive, terminal leave benefits and monetization of leave credits to all qualified Municipal Officials and Employees and other programs of the Municipality;

WHEREFORE, BE IT ENACTED, by the Sangguniang Bayan duly assembled that:

SECTION 1. There is an available amount of Two Million Nine Hundred Seventeen Thousand Eight Hundred Seventeen Pesos and Four Centavos (P2,917,817.04) representing Personal Services Savings (Vacant Positions) from January to June 2017;

SECTION 2. Appropriation. The amount of Two Million Nine Hundred Seventeen Thousand Eight Hundred Seventeen Pesos and Four Centavos (P2,917,817.04) is hereby reverted and shall be appropriated for the following, as follows:
