“MUNICIPAL ORDINANCE NO. 2017-17

**AN ORDINANCE ABOLISHING THE POSITION OF ADMINISTRATIVE AIDE IV
(STENOGRAPHER) WITH SALARY GRADE 4 UNDER THE
OFFICE OF THE SANGGUNIANG BAYAN.**

WHEREAS, Section 76 of Republic Act No. 7160 also known as the Local Government Code of 1991 provides that, “Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission”;

WHEREAS, Section 447 of the same Code empowers the Sangguniang Bayan to create positions and determine the powers and duties of officials and employees of the municipality subject to the provisions of pertinent laws and regulations;

WHEREAS, such power carries with it the power to abolish positions if it deems necessary;

WHEREAS, it has been the policy of the municipal government to be responsive and accountable in the delivery of services and facilities;

WHEREAS, the abolished position does not affect the rights of incumbent employees as the said position is already declared vacant and no longer needed;

WHEREAS, there is a need to abolish the above-mentioned position and eventually create position responsive to the needs of the municipal government;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of San Nicolas, Ilocos Norte in session duly assembled, that:

SECTION 1. The Administrative Aide IV (Stenographer) with Salary Grade 4 is hereby abolished.

SECTION 2. In the interest of public service and the multifarious programs and activities of the municipal government in the delivery of basic services and facilities, there shall be created position through an appropriate ordinance to address the gaps in the organizational structures accordingly.

SECTION 3. Separability Clause. - If for any reason, any section of this Ordinance is declared illegal or unconstitutional, other sections hereof which are not affected shall continue to be in full force and effect.

SECTION 4. Repealing Clause. - All previous issuances, ordinance, rules and regulations, provisions or parts thereof, which are inconsistent or in conflict with the provisions of this Ordinance, are hereby repealed or modified accordingly.


SECTION 5. Effectivity Clause. - This Ordinance shall take effect immediately upon approval.




