## **"RESOLUTION NO. 2016-111**

## A RESOLUTION ADOPTING THE PROPOSED COMPREHENSIVE LAND USE PLAN (CLUP) OF THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE.

WHEREAS, pursuant to Section 20, par. C, of RA 7160, otherwise known as the Local Government Code of 1991, the Municipality of San Nicolas, Ilocos Norte recognizes the need to formulate a Comprehensive Land Use Plan (CLUP) that shall be the framework and basis for the utilization of land resources of San Nicolas, Ilocos Norte;

**WHEREAS**, the existing CLUP which is part and parcel of the Zoning Ordinance which was enacted way back in 2002 of the municipality is apparently outdated considering the present growth and development of the town;

**WHEREAS,** it is just proper to make the necessary revisions to keep abreast with said development and to meet the needs of investors as well as the other sectors in the community;

**WHEREAS**, the proposed CLUP was submitted to the Sangguniang Bayan for further review which promptly conducted a public hearing where stakeholders were invited to ventilate their concerns and provide some inputs in the finalization of the aforementioned plan;

**WHEREAS,** the Municipal Planning and Development Office spearheaded the formulation of the CLUP and the inputs derived from the consultations were incorporated in the plan which are subject to existing laws and regulations;

**WHEREAS**, the Sangguniang Bayan after thorough review and evaluation of the said proposed CLUP, finds it to be extensive, realistic and consistent with pertinent laws governing the utilization of land resources;

WHEREFORE, BE IT RESOLVED as it is hereby RESOLVED by the Sangguniang Bayan assembled in session to adopt and approve the proposed Comprehensive Land Use Plan (CLUP) of the Municipality of San Nicolas, Province of Ilocos Norte.
