“RESOLUTION NO. 2016-112

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE MARIANO MARCOS STATE UNIVERSITY REPRESENTED BY ITS ACTING PRESIDENT, DR. PRIMA FE R. FRANCO FOR THE PROJECT TITLED IMPROVEMENT OF PRODUCTION OF DAMILI.

WHEREAS, Damili-making, known to be the municipality’s centuries-old industry, has been contributing for the sustainable development of the municipality especially in the lives of thousands of San Nicoleños and Ilocanos, thus, one of the most revered industries in the country;

WHEREAS, it has become the source of identity, pride, and inspiration of the municipality and its people;

WHEREAS, the project titled **IMPROVEMENT OF PRODUCTION OF DAMILI** intends to preserve, promote, and improve the damili products;

WHEREAS, the parties recognize the true worth of this project as a contributory to the conservation and promotion of San Nicolas culture and arts;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.

– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, this authority shall be subject to existing laws on the auditing and accounting rules and regulations;

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with the Mariano Marcos State University Represented by its Acting President, Dr. Prima Fe R. Franco for the project titled Improvement of Production of Damili.

RESOLVED, FINALLY, to transmit copy of this resolution to all concerned for their information and appropriate action.


On motion of Member Norberto S. Dadiz, Jr., duly seconded, foregoing resolution was unanimously approved.




