"RESOLUTION NO. 2016-113"

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE MARIANO MARCOS MEMORIAL HOSPITAL AND MEDICAL CENTER (MMMHMC) REPRESENTED BY ITS CHIEF OF HOSPITAL ADMINISTRATION, DR. MA. LOURDES K. OTAYZA FOR THE ANTI-DRUG ABUSE AND REHABILITATION PROGRAM TITLED "SAN NICOLAS HEALING TIME".

WHEREAS, the Mariano Marcos Memorial Hospital and Medical Center, a government hospital facility, is fully supportive of the national government's thrust of providing the Filipinos viable and quality health service, especially to those who have less in life;

WHEREAS, the LGU of San Nicolas is fully aware of its role and mandate to assist its citizens including those involved in prohibited drugs in their medical and health needs;

WHEREAS, statistics at the MMMHMC show that a considerable number of their patients are from the Municipality of San Nicolas, Ilocos Norte;

WHEREAS, due to the hard stance of the National Government in eradicating drugs, a present considerable number of residents in the municipality of San Nicolas voluntarily submitted themselves to authorities to avail of the town's reform program for drug personalities;

WHEREAS, the LGU is of the belief that people engaged in prohibited drugs deserve a chance to reform and return back to the mainstream of society;

WHEREAS, the First and the Second parties, agree to mutually implement a beneficial health and rehabilitation program for drug dependents to enable them to cease substance abuse in order to avoid the psychological, legal, financial, social and physical consequences that can be caused, especially by extreme abuse of the sick and to optimize the use of government resources for noble programs;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

XXX XXX XXX

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

- (b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:
- (vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance."

WHEREAS, this authority shall be subject to existing laws on the auditing and accounting rules and regulations;

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with the Mariano Marcos Memorial Hospital and Medical Center (MMMHMC) represented by its Chief of Hospital Administration, Dr. Ma. Lourdes K. Otayza for the project titled, "Anti-Drug Abuse and Rehabilitation Program".

RESOLVED, FINALLY, to transmit copy of this resolution to all concerned for their information and appropriate action.

On motion of Member Orlando B. Badua, duly seconded, foregoing resolution was unanimously approved.
