**“RESOLUTION NO. 2016-146**

**A RESOLUTION ENDORSING THE PROJECT PROPOSAL OF THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE, WHICH IS THE CONSTRUCTION/ INSTALLATION OF A WASTE WATER TREATMENT FACILITY AT THE PUBLIC MARKET, TO THE REGIONAL DEVELOPMENT COUNCIL THRU THE NATIONAL ECONOMIC DEVELOPMENT AUTHORITY (NEDA) REGIONAL OFFICE I, IN RESPONSE TO THE PROJECT CALL OF THE SAID NATIONAL GOVERNMENT AGENCY PURSUANT TO ENERGY REGULATION 1-94.**

**WHEREAS**, the sewage disposal and the wastewater treatment at the Public Market has been a recurring problem at the San Nicolas, Public Market causing inconvenience to the consumers, market goers, including tourists and balikbayans, as well as the market vendors and stall occupants;

**WHEREAS**, without a doubt, the Public Market is a viable source of local revenues which are in turn utilized for the developmental projects of the municipality as well as other social services intended to the townspeople;

**WHEREAS**, concomitant to the mandate of the Local Government Code for Local Government Unit (LGU) to source out funds for the improvement of its services and facilities, the present dispensation aims to be one of the recipients of projects to be funded out from the accumulated fund share of the region from the commercial operations of power plants in the region;

**WHEREAS**, the Project Call is timely as the construction/installation of a wastewater treatment facility at the Public Market has been identified as one of the priority concerns of the LGU;

**WHEREFORE**, be it **RESOLVED** as it is hereby **RESOLVED** by the Sanguniang Bayan assembled in session, to endorse the project proposal of the Municipality of San Nicolas, Province of Ilocos Norte which is the construction/installation of a wastewater treatment facility at the Public Market;

**RESOLVED FURTHER** to transcribe copies of this resolution and furnish same to the NEDA Regional Office I for their perusal and consideration.


On motion of Member Efren C. Butay, duly seconded, the foregoing resolution was unanimously approved.
