**“RESOLUTION NO. 2016-197**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE EARLY CHILDHOOD CARE AND DEVELOPMENT COUNCIL (ECCDC) REPRESENTED BY ITS EXECUTIVE DIRECTOR, DR. TERESITA G. INCIONG REGARDING THE ESTABLISHMENT OF A NATIONAL CHILD DEVELOPMENT CENTER (NCDC).**

**WHEREAS**, the ECCDC is duly mandated in accordance with Republic Act 10410 (Early Years Act) to institutionalize a National System for Early Childhood Care and Development (ECCD) that is comprehensive, integrative and sustainable that will involve multi-sectoral and interagency collaboration at the national and local levels to promote the optimum growth and development of Filipino children ages zero (0) to four (4) years;

**WHEREAS**, in pursuance of the above mandate, the ECCDC aims to further enhance the provision of quality home-based and center-based ECCD programs in partnership with stakeholders;

**WHEREAS**, the ECCDC intends to establish National Child Development Centers (NCDCs) including the provision of contents and teacher to serve as its laboratory of the different modes of delivery of center-based ECCD programs;

**WHEREAS**, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

*Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:*

xxx

xxx

*(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.*

**WHEREAS**, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.  
– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

**WHEREAS**, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

**RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with the Early Childhood Care and Development Council (ECCDC) Represented by Dr. Teresita G. Inciong, Executive Director regarding the Establishment of a National Child Development Center (NCDC).

**RESOLVED, FINALLY**, to transmit copy of this resolution to all concerned offices for their information and appropriate action.

On motion of Member Domingo C. Ambrocio, Jr., duly seconded, foregoing resolution was unanimously approved.


