WHEREAS, the Municipal Government is hopeful to forge a closer ties with the Bingao National High School for a better San Nicolas;


WHEREAS, their valuable support and contributions marked the success of every event of Damili Festival 2015, thus, it is just fitting for them to be given due recognition;
