WHEREAS, in view of the approval of the separation and grant of independence of the *San Nicolas National High School- Bingao Campus* (Annex) from its mother school effective School Year 2015-2016, there is a need to rename it so that it will have a distinct identity and recognition of its own;

WHEREAS, upon prior consultation with the parents in the locality and of the Municipal School Board as manifested thru its MSB Resolution No. 2014-02, it has been recommended that it be named as **BINGAO NATIONAL HIGH SCHOOL (BNNHS)**, consistent with the cultural and historical name of the place of said school specifically located along the stretch of the national highway going to Batac City;

WHEREAS, on Motion of Hon. Atty. Reynaldo A. Corpuz, duly seconded by Hon. Efren C. Butay and Hon. Orlando B. Badua, it is hereby **RESOLVED** as it is hereby –

RESOLVED to earnestly request the National Historical Commission of the Philippines (NHCP) to manifest its conformity and/or no objection on the renaming of the said annex of the San Nicolas National High School (SNNHS), Bingao Campus to BINGAO NATIONAL HIGH SCHOOL.


RESOLVED FINALLY, to transcribe and furnish this Resolution to the said National Historical Commission of the Philippines for their due consideration.


