WHEREFORE, all the foregoing considered, be it resolved as it is hereby – **RESOLVED**, to **FAVORABLY INDORSE** the implementation of


RESOLVED FINALLY, to furnish this resolution, as a collective manifestation of endorsement, to the management of the CDEA Enterprises for their information and guidance.
