“RESOLUTION NO. 2016-52

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. MELANIE GRACE P. VALDEZ TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE MARIANO MARCOS MEMORIAL HOSPITAL AND MEDICAL CENTER (MMMH & MC) REPRESENTED BY ITS CHIEF OF HOSPITAL ADMINISTRATION, DR. OTAYZA FOR THE FACILITATION OF THE PROVISION OF MEDICAL ASSISTANCE TO PATIENTS ADMITTED IN THE SAID HEALTH INSTUTION.

WHEREAS, the Mariano Marcos Memorial Hospital and Medical Center, a government hospital facility, is fully supportive of the national government’s thrust of providing the Filipinos viable and quality health service, especially to those who have less;

WHEREAS, statistics at the MMMH & MC show that a considerable number of their patients are from the Municipality of San Nicolas, Ilocos Norte who are mostly indigents who cannot shoulder all their hospital bills and other medical expenses;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.

– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive, Honorable Melanie Grace P. Valdez to Enter Into A Memorandum of Agreement (MOA) with the Mariano Marcos Memorial Hospital and Medical Center (MMMh & MC) Represented by its Chief Of Hospital Administration, Dr. Otayza for the Facilitation of the Provision of Medical Assistance to Patients Admitted in the said Health Institution.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;


On joint motion of Members Aladine T. Santos and Orlando B. Badua, duly seconded, foregoing resolution was unanimously approved.
