WHEREAS, the municipality and the second district of the Province of Ilocos Norte have shares amounting to P4,185,242.00 and P14,421,164.00 respectively;

RESOLVED FURTHER to transcribe copies of this resolution and furnish same to all concerned, for their information and guidance.


On motion of Member Aladine T. Santos, duly seconded, foregoing resolution was unanimously approved.
