# **"RESOLUTION NO. 2016-79**

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. MELANIE GRACE P. VALDEZ TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE I REPRESENTED BY ITS REGIONAL DIRECTOR, MARCELO NICOMEDES J. CASTILLO FOR STRENGTHENED PARTNERSHIP AND FOR THE MORE EFFECTIVE IMPLEMENTATION OF PROGRAMS, PROJECTS, AND ACTIVITIES AIMED AT ERADICATING POVERTY AND PEOPLE EMPOWERMENT.

**WHEREAS**, the Department of Social Welfare and Development (DSWD) is the government agency that is primarily responsible in delivering coordinated social protection services aimed at eradicating poverty;

**WHEREAS**, DSWD envisions a society where the poor, vulnerable and disadvantaged individuals, families, and communities are empowered for an improved quality of life;

**WHEREAS**, DSWD takes protection of the poor and marginalized as its main mission which it seeks to achieve through the implementation of various projects, programs, and activities collectively referred to as "Social Protection";

**WHEREAS**, the Local Government Units are mandated by law to address the needs of its constituents, empower its people and allow them widest possible participation in government affairs;

**WHEREAS**, the municipality intends to address the poverty of its citizens through the implementation of programs, locally generated or in coordination with National Government Agencies;

**WHEREAS**, the municipality recognizes that the projects being implemented by the DSWD are designed to deliver coordinated social protection services and are aimed at addressing poverty;

**WHEREAS**, the municipality also recognizes that a partnership with DSWD will contribute in the attainment of the program objectives and will bring forth reduced poverty among the citizens of the municipality;

**WHEREAS**, there is a need to authorize the Local Chief Executive to enter into a Memorandum of Agreement with DSWD for strengthened partnership and for the more effective implementation of programs, projects, and activities aimed at eradicating poverty and people empowerment;

**WHEREAS**, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. -

- (b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:
- (vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance."

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby RESOLVED by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive, Honorable Melanie Grace P. Valdez to Enter Into A Memorandum of Agreement (MOA) with the Department of Social Welfare and Development Field Office I Represented by its Regional Director, Marcelo Nicomedes J. Castillo covering the following programs:

- 1. Supplementary Feeding Program;
- 2. Pantawid Pamilyang Pilipino Program;
- 3. Sustainable Livelihood Program;
- 4. Kapit-bisig Laban sa Kahirapan-Comprehensive Integrated Delivery of Social Services (KALAHI-CIDSS);
- 5. Social Pension Program;
- 6. Supplemental Feeding Program; and
- 7. Bottom-Up Budgeting Projects.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;
