A RESOLUTION AUTHORIZING THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE TO ENROLL IN THE LANDBANK INSTITUTIONAL INTERNET BANKING OR “WE ACCESS” FOR THE PAYMENTS OF THE OBLIGATIONS OF THE MUNICIPALITY TO THE PAG-IBIG, BIR AND OTHER AGENCIES INVOLVED.

WHEREAS, the advent and the internet had a breakthrough in almost every aspect of transactions may it be private or in government transactions and services offered to the public;

WHEREAS, the municipality, to keep abreast with this trend shall adopt schemes and devises applicable to its daily transactions especially those involving the financial management/payment of obligations of the Local Government Unit (LGU);

WHEREAS, the LGU thus endeavors to do the following:

1. Subscribe to the Land Bank of the Philippines’ (LBP’s) internet banking facility known as “We Access”; and
2. Designate authorized signatory to enroll and designate authorized user/s in the Land Bank We Access.

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Municipality of San Nicolas, Ilocos Norte to:

1. Execute/sign all documents necessary to subscribe to LBP’s “We Access”;
2. Shall designate/authorize personnel to act as “maker” or “authorizer” for the company’s access to LBP’s We Access banking facility;

- 3. amend/add/delete enrolled deposit account/s as source and/or destination account/s, access rights to the We Access modules, authorization rules and/or any information on the original and succeeding enrollments.

And that the same is hereby confirmed;

THAT, this is an addendum to the signatories of the submitted resolution for account opening;

RESOLVED, FINALLY, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;

On motion of Member Oscar V. Domingo, duly seconded, foregoing resolution was unanimously approved.


