A RESOLUTION EARNESTLY REQUESTING ENGR. MATHIAS L. MALENAB, DISTRICT ENGINEER, OF THE 2ND ENGINEERING DISTRICT OFFICE OF THE DPWH TO FINANCIALLY ASSIST MUNICIPALITY OF SAN NICOLAS FOR THE ASPHALT OVERLAY OF THE OUTER LANES OF THE MANILA NORTH ROAD (MNR) WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY.

WHEREAS, there is an on-going project funded by the Department of Public Works and Highways along the Manila North Road (MNR) which is the asphalt overlay on the said road;

WHEREAS, it has been observed that the asphalt overlay covers only the two center lanes of the MNR which is about three to four inches thick leaving the outer lanes uneven with the asphalted center lanes;

WHEREAS, motorists complain that the road condition poses hazard to them because it might cause their cars and others vehicles to slide especially motorcycles and may become prone to accidents and inconveniences;

WHEREAS, the Local Government Unit of San Nicolas deems it safer for motorists if the outer lanes of the MNR would be also asphalted;

WHEREFORE, be it **RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan in session to earnestly request Engr. Mathias L. Malenab, District Engineer, of the 2nd Engineering District Office of the DPWH to financially assist Municipality of San Nicolas for the Asphalt Overlay of the Outer Lanes of the Manila North Road (MNR) within the territorial jurisdiction of the municipality;

RESOLVED, FURTHER, to transmit copy of this resolution to the Office of the 2nd Engineering District Office of the Department of Public Works and Highways (DPWH) for his information.


On motion of Member Jessie Julito P. Pumaras, Sr., duly seconded, foregoing resolution was unanimously approved.
