A RESOLUTION EARNESTLY REQUESTING THE GEN. RICARDO VISAYA (RET.), ADMINISTRATOR, NATIONAL IRRIGATION ADMINISTRATION FOR THE CONCRETE PAVING OF FARM TO MARKET ROAD AT BARANGAY 16, SAN MARCOS AND BARANGAY 19, SAN LORENZO.

WHEREAS, it is imperative for the Local Government Unit to draw the road map aimed to improve the quality of life of its inhabitants, pursuant to Section 16 of the Local Government Code of 1991;

WHEREAS, consistent with the National Government's program of poverty alleviation, the municipality has adopted plans and programs to address the needs of the farmers to enhance their earning capacity;

WHEREAS, component of this program is the construction of Farm to Market Roads which if implemented will necessary facilitate the transport of Farm produce directly to the market, thus resulting increase of income of these farm cultivators;

WHEREAS, most of these plans remain unimplemented due to the inadequate resources of the Municipal Government, hence the town is constrained to seek the assistance of National Government agencies tasked for the implementation of the agricultural program;

WHEREFORE, be it RESOLVED as it is hereby resolved by the Sangguniang Bayan assembled in session to earnestly request the Gen. Ricardo Visaya (Ret.), Administrator, National Irrigation Administration for the Concrete Paving of Farm to Market Road at Barangay 16, San Marcos and Barangay 19, San Lorenzo.
