"RESOLUTION NO. 2017-149

A RESOLUTION ALLOWING THE CONSTRUCTION OF A GASOLINE STATION AT BRGY. 22, SAN GUILLERMO, SAN NICOLAS, ILOCOS NORTE IN COMPLIANCE TO ENVIRONMENTAL PERMITS AS REQUIRED BY THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES.

WHEREAS, Mrs. Mary Ann Ang and Mr. Victor Ang, proponents, have applied in the municipality, for a business permit to operate a gasoline station to be located at Brgy. 22, San Guillermo;

WHEREAS, the site where the proposed establishment will be erected is now classified as a residential/commercial area, pursuant to the new Comprehensive Land Use Plan (CLUP) of the municipality which is now under review of the Provincial Land Use Committee;

WHEREAS, Mr. Victor Ang has already secured and submitted other pertinent requirements for him to be issued a locational clearance, including among others resolutions of no objection from Brgy. 22, San Guillermo and consent of nearby residents;

WHEREAS, it is customary and by law that damages to property and persons arising from fault and negligence in the operation of the gasoline station shall be borne by the owner or proprietor of the business establishment;

WHEREAS, the Sangguniang Bayan finds no legal impediment to issue a resolution allowing the putting up of a gasoline station at Brgy. 22, San Guillermo, San Nicolas, Ilocos Norte, subject to compliance with existing ordinances and national laws, relative to the operation of such nature of business as may be imposed by the Sangguniang Bayan;

WHEREFORE, be it resolved, as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session to allow as it hereby grants the request of Mrs. Mary Ann Ang and Mr. Victor Ang to establish a gasoline station at Brgy. 22, San Guillermo.

RESOVED FURTHER, to transcribe copies of this resolution and furnish same to all concerned for their information appropriate action.
