"RESOLUTION NO. 2017-154"

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) REPRESENTED BY ITS REVIONAL DIRECTOR MA. VICTORIA V. ABRERA FOR THE IMPLEMENTATION OF ECOLOGICAL SOLID WASTE MANAGEMENT IN PUBLIC MARKET.

WHEREAS, Section 10 of Republic Act No. 9003, known as the Ecological Solid Waste Management Act of 2000 states that pursuant to the relevant provisions of the Local Government Code of 1991, (RA 7160) local government units are primarily responsible for the implementation and enforcement of the provisions of RA 9003;

WHEREAS, the Ecological Solid Waste Management Act of 2000 (RA 9003), provides for an Ecological Solid Wastes Management System, creating the necessary institutional mechanisms and incentives, and appropriating funds therefor to guide local government units (LGUs) in the achievement of the objectives of the Act;

WHEREAS, Section 20 of RA 9003 requires LGUs to divert solid waste from waste disposal facilities through re-use, recycling and composting and other resource recovery activities;

WHEREAS, through the Waste Analysis and Characterization Study (WACS) conducted in the municipalities of the Region, biodegradable wastes constitute the bulk of wastes generation and these come from public markets;

WHEREAS, Section 8 of the same Act, mentions the role of DENR to provide technical and other capability building assistance and support to the LGUs in the development and implementation of local solid waste management plans and programs;

WHEREAS, in order for LGUs to fulfill one of their responsibilities to divert solid wastes from going into disposal facilities, the DENR trough the Environmental Management Bureau (EMB) launches the establishment and institutionalization of Solid Wastes Management System in Public Markets:

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

- (b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:
- (vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance."

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED to authorize the Local Chief Executive to enter into a Memorandum of Agreement with the Department of Environment and Natural Resources (DENR) represented by its Regional Director Ma. Victoria V. Abrera for the Implementation of Ecological Solid Waste Management in Public Market.

RESOLVED, FURTHER, to transmit copy of this resolution to all concerned offices for their information and appropriate action.
