"RESOLUTION NO. 2017-155"

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE MARIANO MARCOS STATES UNIVERSITY (MMSU) FOR THE IMPLEMENTATION OF THE COMMUNITY BASED - REHABILITATION (CBR) PROGRAM.

WHEREAS, MMSU through its Extension Services endeavors to disseminate and promote the utilization of developmental information and technologies among the public through deliberate, effective and efficient ways in partnership with other development agencies, government units, and peoples organizations;

WHEREAS, LGU recognizes its mandate under the Local Government Code to conduct direct extension and technology transfer and promotion activities through all feasible and viable means including establishing partnership with relevant development agencies;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

XXX XXX XXX

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

- (b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:
- (vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance."



NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED to authorize the Local Chief Executive to enter into a Memorandum of Agreement with the Mariano Marcos States University (MMSU) for the Implementation of the Community Based – Rehabilitation (CBR) Program.

RESOLVED, FURTHER, to transmit copy of this resolution to all concerned offices for their information and appropriate action.
