**“RESOLUTION NO. 2017-156**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A  
CONTRACT WITH AN AUTHORIZED SURVEYING FIRM FOR THE SURVEY OF THE LOT  
NORTH OF THE MUNICIPAL SLAUGHTERHOUSE TO SUBSTANTIATE THE CLAIM OF TITLE  
OR OWNERSHIP OF THE LGU.**

**WHEREAS**, the municipality deems to secure the services of an authorized surveying firm necessary for the survey of a parcel land located at the north of the Municipal Slaughterhouse;

**WHEREAS**, the undertaking is necessary in order for the municipality to substantiate its claim of title and ownership over the aforementioned lot;

**WHEREAS**, the lot shall be used in the expansion of the Municipal Slaughterhouse to conform with national standards and specifications of the National Meat and Inspection Commission;

**WHEREAS**, Section 444 of the Local Government Code of 1991 requires prior authorization from the Sangguniang Bayan before the Local Chief Executive can effectively execute or sign documents for and on behalf of the municipality, to wit:

- (vi) Upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

**WHEREAS**, after thorough study and deliberation, the Sangguniang Bayan deems it necessary and proper to approve this resolution;

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED** to authorize the Local Chief Executive to enter into an agreement with authorized surveying firm for the survey and consolidation and preparation of plans with respect to all unregistered parcels of land owned by the municipality;

**RESOLVED, FURTHER**, to furnish copy of this Resolution to all concerned, for their information and guidance.

On motion of Member Norberto S. Dadiz, Jr., duly seconded, the foregoing resolution was unanimously approved.


