"RESOLUTION NO. 2017-159

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE MARIANO MARCOS STATE UNIVERSITY (MMSU) FOR INDUSTRY IMMERSION PROGRAM OR ON-THE-JOB TRAINING.

WHEREAS, the Mariano Marcos State University offers Communication Arts Program that require students to undergo on-the-job training in the public or private offices as a requirement for graduation in order to expose them in actual work situations as a means to enhance their formal training;

WHEREAS, the Municipality of San Nicolas willingly accepts on-the-job trainees officially enrolled in the University subjects to the terms and conditions provided for in the Memorandum of Agreement;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

XXX XXX XXX

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

- (b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:
- (vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance."



NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED to authorize the Local Chief Executive to enter into a Memorandum of Agreement with the Mariano Marcos State University (MMSU) for Industry Immersion Program of On-The-Job Training.

RESOLVED, FURTHER, to transmit copy of this resolution to all concerned offices for their information and appropriate action.
