A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE-REGIONAL FIELD OFFICE I REPRESENTED BY ITS REGIONAL EXECUTIVE DIRECTOR, NARCISO A. EDILLO, MA.ED AND REGIONAL AGRICULTURE AND FISHERY COUNCIL (RAFC) REPRESENTED BY ITS CHAIRMAN, MR. VINCENT A. ADORNA FOR THE PROVISION OF MULTI-PURPOSE CULTIVATOR.

WHEREAS, the “Organic Agriculture Program” of the Department of Agriculture, provided the national directions and framework for harmonizing local initiatives of the program;

WHEREAS, the Organic Agriculture Act of 2010 is declared as policy of the state to promote, propagate, develop further and implement the practice of organic agriculture in the Philippines that will cumulatively condition and enrich the fertility of the soil, increase farm productivity, reduce pollution and destruction of the environment, prevent the depletion of natural resources, further protect the health of farmers, consumers, and the general public, and save on imported farm inputs;

WHEREAS, the “DA-RFO” I has the administrative and technical capability to implement the “On-Farm Mechanization Program: Provision of Farm Mechanization Facilities and Equipment to Farmers Associations”;

WHEREAS, the “DA-RFO I” has allotted funds for the procurement of Multi-Purpose Cultivator as per General Appropriation Act (GAA) 2017 RA 10924.

WHEREAS, Section 444 of the Local Government Code of 1991 requires prior authorization from the Sangguniang Bayan before the Local Chief Executive can effectively execute or sign documents for and on behalf of the municipality, to wit:

(vi) Upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, after thorough study and deliberation, the Sangguniang Bayan deems it necessary and proper to approve this resolution;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED to authorize the Local Chief Executive to enter into a Memorandum of Agreement (Moa) With The Department Of Agriculture-Regional Field Office I Represented By Its Regional Executive Director, Narciso A. Edillo, Ma.Ed and Regional Agriculture and Fishery Council (RAFC) represented by its Chairman, Mr. Vincent A. Adorna for the Provision of Multi-Purpose Cultivator.

RESOLVED, FURTHER, to furnish copy of this Resolution to all concerned, for their information and guidance.


On motion of Member Ariel B. Villa, duly seconded, the foregoing resolution was unanimously approved.
